Name, brief description and file number: (SCH#: 2009- _____) This project proposes a watershed based invasive non-native plant control and riparian restoration program on the San Diego River Watershed. The riparian habitat is estimated to be 6,642 acres with an additional 354 acres occupied by invasive non-native plants. Total riparian habitat after control/restoration would be 6,996 acres. The project involves removal of *Arundo Donax* and re-vegetation by planting native species. *Arundo* and other invasive non-native plants pose a serious threat to the native flora and fauna, and are a significant flood and fire risk to the community. *Arundo* alters the flood regime by blocking flows with its thick growth, creates unstable banks due to its poorly developed root systems, and contributes to bridge and flood control structure failure. The typical restoration process for *Arundo* begins in the Fall, which avoids/minimizes impacts to the breeding/reproductive season for wildlife, fish and native plants.

Location: The San Diego River Watershed riparian habitat for this project is in the lower watershed, and includes the cities of San Diego, El Cajon, and Santee in San Diego County.

A brief statement of the reasons supporting the Board of Directors' findings areas as follows: All potential impacts analyzed in the initial study were determined to be below a level of significance by measures incorporated into the project design.
